Since opening it's doors in March of 2019, FPTV has served families experiencing homelessness in the Tigard-Tualatin, West Linn-Wilsonville, Lake Oswego and Sherwood school districts. Due to the public health crisis created by Covid-19, they began serving houseless individuals in addition to houseless families in June of 2020. 2020 showed a tremendous year of growth in services provided with 45 households enrolled in program totaling 6,165 bed nights of shelter, over 18,000 meals provided with 87% of guests entering stable housing upon exit from program. 101 individuals were provided prevention and diversion services to keep them from losing their homes and 81 individuals accepted stabilization assistance such as utility bill help to keep them in their homes.
